## MINNESOTA WOOD CARVERS ASSOCIATION SHOW RULES

1. All items must be the exhibitor's own handiwork, or that of a member of his or her immediate household, who should be present at the show.
  2. Exhibitors must supply their own lighting fixtures and cords, risers and riser covers, and any other display fixtures. The mall will supply table skirting and the main table cover.
  3. NO POWER CARVING OR WOODBURNING during the show.
  4. Selling is not allowed at this show. You may, however, provide a business card, address or telephone information so you may be contacted at a later date. In this context, selling goods or services includes: taking orders, delivering goods to a buyer, quoting, or any activity which could be construed as engaging in selling on the mall premises.
  5. Fee per table or space is \$10.00 for first one, \$5.00 each thereafter (tables are 30" x 72"). Chairs are \$1.00 each, or you may bring your own chairs.
  6. For insurance purposes, all exhibitors **must** be Minnesota Wood Carver Association members. Membership fee is \$7.50 per year. An electronic subscription to the *Carver's News* is included.
- Encourage visitors to register for beginner classes and become woodcarvers.
